

# USTDA DEFINITIONAL MISSION TO INDONESIA Transportation Infrastructure Project Identification – 2015

#### Overview and Objectives

The U.S. Trade and Development Agency has selected Emerging Markets Infrastructure LLC, working in cooperation with 3E Consulting LLC, to perform a Definitional Mission (DM) for transportation infrastructure projects in Indonesia. The purpose of the Mission is to identify, evaluate, and recommend projects for future USTDA funded technical assistance and feasibility studies. The DM Team will visit Indonesia June 8-17, 2015 to meet with key stakeholders in the transportation sector.

# About the U.S. Trade and Development Agency

USTDA (www.ustda.gov) is an independent U.S. Government Agency that provides grant funding to overseas project sponsors for the planning of projects that support the development of modern infrastructure and an open trading system. The hallmark of USTDA development assistance has always involved building partnerships between U.S. companies and overseas project sponsors to bring proven private sector solutions to developmental challenges.

### The Methodology

The DM Team will work with key public and private sector stakeholders in the Indonesian transportation sector to identify priority projects that meet USTDA criteria. Once projects are identified, the team will prepare terms of reference for technical assistance and feasibility studies to help advance those projects. If approved by both the project sponsor and USTDA, a grant will be made to the host country project sponsor, who will then solicit and contract with a U.S. company to perform the study. The DM Team will not perform the recommended studies.

## What Types of Projects?

The team is looking for port, rail, and aviation related projects that are in the planning phase and, if implemented, present opportunities for significant export of U.S. goods and services. Projects should be financially viable and have prospective sources of financing available for implementation.

### Who Can Be Project Sponsors?

Project sponsors may be Indonesian public sector (government) organizations or private sector companies. The project sponsors should be prepared to present detailed project background information and to be able to assist in the development of a detailed project justification and terms of reference for the proposed USTDA-funded study.
